A Letter from Kendra Wyckoff, Executive Director

Dear Friends

For over 27 years, Peace House has strived to provide high quality services and care to survivors of domestic abuse. Your generosity and commitment allow us to work toward continuous growth; better equipping our team to meet the needs of survivors and to advance efforts building a society where all persons can live without fear, abuse, coercion, oppression, and violence.

From our start in 1995, our focus has always been on safety and providing immediate shelter resources to thousands of women, children and men fleeing an unsafe home or relationship. We have become a larger and more mature organization that continues to evolve and progress in directions resulting in impactful and high-quality victim services to those in need. The Peace House of today is committed to comprehensive services including two residential programs and wraparound supportive services such as clinical counseling, legal and housing advocacy, case management, and specialized sexual assault advocacy. Our team also addresses prevention efforts by providing education to youth and the broader community, with goals of fostering healthy relationships and strengthening families.

The development of our new sexual assault program, including a Hospital Response Team is a significant milestone in better addressing the unique needs of sexual assault survivors in Summit and Wasatch counties. This expansion of services drove Peace House to broaden its mission and vision. In 2022 after a process of shared strategic reflection by the staff and Board of Directors, a new mission and vision were created and adopted with an emphasis on interpersonal violence and abuse to communicate that Peace House is here to help both domestic violence and sexual assault survivors.

Vision: Peace House envisions communities free of interpersonal violence and abuse.

Mission: Peace House is dedicated to ending interpersonal violence and abuse, and empowering survivors to heal and thrive by providing support services, safe housing, and prevention education.

This annual report highlights our accomplishments over the past year and celebrates a story of resilience and healing. We recognize that the pursuit of communities free of interpersonal violence and abuse is a collective effort and we would not be where we are today without your gifts and support. Thank you to all our funders, donors, staff, volunteers, and community partners for supporting the essential lifesaving and changing programs at Peace House.


We are looking forward to another year of offering resources that address healing, safety, and empowerment for survivors and collaborating with our community members as we work in unity to advance our mission and vision.

Statement of Financial Position



Programs and Services

Clinical Therapy and Case Management:

We know that everyone's situation is different. Our clinical team provides trauma-informed services such as therapy and individualized case management to support increased safety and foster the healing process.





Transitional Housing:

Creating a holistic safe, continuum of care for individuals and families in unsafe situations is critical to our mission. Our transitional housing program provides a secure, safe, supportive longer term housing option for survivors and their children while they increase their self-sufficiency and rebuild their lives.

Education and Awareness:

Knowing how to approach a conversation about abuse can be tough. Our prevention education team provides workshops, training, and presentations to youth and adults in our community to help them better understand the signs of abuse, how to identify safe support systems, and how we all can help prevent interpersonal violence and abuse.





Peace House volunteers are ambassadors of our mission.

They may help at an event, participate as a member of our hospital response team, greet survivors when visiting our campus, or participate in a service project. We are grateful for the time, talents, and effort our team of amazing volunteers dedicates to Peace House.



Peace House, alongside many criminal justice partners has begun to work on addressing gaps in services and support for sexual assault survivors.

This has resulted in a new program at Peace House specifically designed to provide advocacy to victims of sexual assault when presenting at the hospital and/or receiving a forensic exam. A Peace House advocate attends the exam to provide emotional support, information and resources and links the victim to other appropriate services at Peace House such as counseling or shelter. Prior to this program being implemented, victims were referred outside of the community for this support.



Sexual Assault Services:

Our professionally trained advocates are confidential communicators who provide sexual assault advocacy to victims while they navigate the impact of sexual assault within their daily lives. Hospital response provides in person support to victims of rape and sexual assault while they seek medical care and/or a forensic exam at a hospital or clinic.



Legal Advocacy:

Navigating court and legal systems, filing a protective order or stalking injunction, or understanding victim rights, while balancing an abusive situation can be overwhelming.

Our legal advocates provide emotional support, information and advocacy.

Emergency Shelter:

Finding immediate shelter in an unsafe situation can feel intimidating or out of reach. At Peace House, survivors take comfort in knowing services are available 24/7 and advocates are onsite to provide safety planning and access to essential services during a time of greatest need.





Helpline (800) 647-9161:

The Peace House helpline is available 24/7, 365 days a year for anyone who is—or anyone who may know—someone who is experiencing any form of interpersonal violence. All conversations are completely confidential and can help save a life.



Calls for Help and Support

6,966 calls were answered from survivors, friends, and families who experienced domestic violence

Over the last year, we supported a survivor, Lucy, who fled domestic violence with her young child.

She is an educator, a survivor, a mother and an inspiration.

After accessing our emergency shelter, she entered our transitional housing program where she began to rebuild a life of safety and stability for her small family. Throughout her stay, she engaged in therapy, and legal advocacy, receiving much needed assistance filing a protective order and finalizing a divorce from her abusive partner. She worked with a case manager, carefully mapping out longer-term plans for housing and self-sufficiency.

Lucy applied for affordable housing in Summit and Wasatch counties and worked to maintain a stable income, and credit in good standing. After learning more about the home-buying process from community partners, she connected with a reputable and trusted realtor and embarked on the process. As this process was unfolding the client faced a roadblock- her income no longer qualified her for the Peace House Transitional Housing program. Together with the Peace House team, including our Housing Specialist, a transition plan was determined, and the client entered a month-to-month seasonal housing option as she waited for news on her loan approval. During her first week there, the lender approval process concluded, and her loan was finalized.

Lucy expressed concern that her abuser may try to find her new home. She also shared that she had no furniture and would be sleeping on the floor once moved in. Our case management team worked to mobilize resources through various grants and emergency financial assistance and secured beds and home security cameras for Lucy.

Peace House helped Lucy settle into her new home and adjust to independent living. During her time in the transitional housing program, she accrued rent payments in an escrow account. Her savings help ensure any emergency needs arising from longer term self-sufficiency are better met.

Lucy is so thankful for the life-changing services offered by Peace House. Her story demonstrates that it takes a community, and wrap around support to help someone sustain a life free of violence.

Lucy hasn't just survived, she has thrived.
